

Subject: Release of (Recurring) Rs. 52,50,000/- (Rupees Fifty Two lakhs and Fifty Thousand only) to Financial Advisor & Chief Accounts Officer, Employees Provident Fund Organization (EPFO), Bhavishya Nidhi Bhawan, 14, Bhikaji Cama Place, New Delhi-110066 for incentive to employers in Private Sector for Providing employment to persons with disability.

Sir,

I am directed to convey the sanction of President of India to release of (Recurring) Rs. 52,50,000/- (Rupees Fifty Two lakhs and Fifty Thousand only) to employees Provident Fund Organization (EPFO), Bhavishya Nidhi Bhawan, 14, Bhikaji Cama Place, New Delhi-110066 for incentive to employers in Private Sector for providing employment to persons with disability.

2. The break-up of Rs. 52,50,000/- (Rupees Fifty Two lakhs and Fifty Thousand only) is Rs. 37,50,000/- is for employment of Physically Challenged and Rs. 15,00,000/- is for employment of Physically Challenged(GIA for SCs).
3. Name of the Scheme: Incentive to employers in Private Sector for providing employment to persons with disability.
4. Purpose for which this grant is sanctioned: Advance contribution as **Employer's Share** for running the above Scheme.
5. Certified that this grant has been noted at Sl. No. in Register of Grants (maintained in Form GFR-39).
6. The Grants-in-aid will be regulated in accordance with the provisions contained in the General Financial Rules (GFR), 2005. The Grant-in-aid is also subject to the Chapter 9 of the General Financial Rules, 2005, as amended from time to time and read with the Government of India's decision incorporated there-under, and any other guidelines which may be issued in this regard, and in particular to the following conditions:-



i) All relevant information and documents / certificates as required under GFR 209 have been received.

ii) The EPFO will submit Utilisation Certificate in respect of the above funds as per General Financial Rules to the Sanctioning Authority.

iii) Certified that the pattern of assistance of rules governing such grant-in-aid have received the approval of the Ministry of Finance, as required under Govt. of India Decision No. (1) under DFPR-Rule 20.

iv) The accounts of Employees Provident Fund Organisation (EPFO), Bhavishya Nidhi Bhawna, 14, Bhikaji Cama Place, New Delhi shall be open to be audited by C&AG or by any person authorized by him on his behalf in accordance with the provisions laid down in Section 14 of the C&AG (DPC Act 1971) as amended from time to time.

v) The Accounts of Employees Provident Fund Organization (WEFPO), Bhavishya Nidhi Bhawan, 14, Bhikaji Cama Place, New Delhi Shall Be open for inspection by the Sanctioning Authority and Audit, both by the comptroller & Auditor General of India under the provision of C&AG (DPC Act, 1971) and Internal Audit by the Principal Accounts Office of the Ministry or Department whenever it is called upon to do so.

vi) Grant-in-aid to Employees Provident Fund Organization (EPFO), Bhavishya Nidhi Bhawna, 14, Bhikaji Cama Place, New Delhi is subject to the economy instructions issued from time to time by the M/o Finance or by the Competent Authority.

vii) The Employees Provident Fund Organization (EPFO), Bhavishya Nidhi Bhawna, 14, Bhikaji Cama Place, New Delhi shall furnish to this Ministry monthly progress report on the implementation of the above Scheme both physical and financial achievements in relation to the above Scheme.

viii) Employees Provident Fund Organization (EPFO), Bhavishya Nidhi Bhawan, 14, Bhikaji Cama Place, New Delhi has no utilization certificates as due for submission under the rules under the scheme other Programmes for Welfare of Handicapped of Ministry of Social Justice and Empowerment.

ix) Employees Provident Fund Organization (EPFO), Bhavishya Nidhi Bhawna, 14, Bhikaji Cama Place, New Delhi will confirm that the condition mentioned in the letter are acceptable to him and he is exempted from executing the bond.




