Subject: Release of Grant-in-aid (non-recurring) to Himachal Pradesh University, Shimla-171005 for creation of accessible website of Himachal Pradesh University under the SIPDA Scheme during 2014-15

Sir,

I am directed to convey the sanction of President of India to release of Rs.18,78,762/- (Rupees Eighteen Lakh Seventy Eight Thousand Seven Hundred Sixty Two only) (Rs. 20,00,000/-, sanctioned amount - Rs. 1,21,238/- unspent balance of previous grant-in-aid) to the Finance Officer, Himachal Pradesh University for redevelopment of Accessibility Compliant Web Portal of Himachal Pradesh University, for Persons with Disabilities under the Scheme for Implementation of Persons with Disability Act, 1995 (SIPDA) during 2014-15.

2. Purpose for which this grant is sanctioned: For making the University Website <http://www.hpuniv.nic.in> accessible for the Persons with Disabilities (PWDs).


3. Certified that this sanction has been noted at Sl. No. 13 in Register of Grants (maintained in Form GFR-39) for the year 2014-15.

4. The Grants-in-aid will be regulated in accordance with the provisions contained in the General Financial Rules (GFR), 2005. The Grants-in-aid is also subject to the Chapter 9 of the General Financial Rules, 2005, as amended from time to time and read with the Government of India's decisions incorporated there-under, and any other guidelines which may be issued in this regard, and in particular to the following conditions: -

- (i) All relevant information and documents /certificates as required under GFR 2009 have been received.
- (ii) Certified that the pattern of assistance of rules governing such grants-in-aid have received the approval of the Ministry of Finance, as required under Govt. of India Decision No. (1) under DFPR-Rule 20.
- (iii) The accounts of the Himachal Pradesh University, Shimla shall be open for audit by C&AG or by any person authorized by him on his behalf in accordance with the provisions laid down in Section 14 of the C&AG (DPC Act 1971) as amended from time to time.

(iv) The accounts of the Himachal Pradesh University, Shimla shall be open for inspection by the Sanctioning Authority and Audit, both by the Comptroller & Auditor General of India under the provision of C&AG (DPC Act, 1971) and Internal Audit by the Principal Accounts Office of the Ministry or Department whenever it is called upon to do so.

(v) Grants-in-aid to the Himachal Pradesh University, Shimla is subject to the economy instructions issued from time to time by the Ministry of Finance or by any other Competent Authority.

(vi) (a) It is certified that utilization certificate for Rs. 10,81,662/- (Rupees Ten Lakh Eighty One Thousand Six Hundred Sixty Two only) against grant-in-aid for Rs. 12,02,900/-, last sanctioned to the Himachal Pradesh University during 2007-08 for creation of barrier free facilities has been received. Himachal Pradesh University shall complete all work within 06 months and on completion of the work, the Himachal Pradesh University, will furnish Utilization Certificate and completion certificate for Rs. 20,00,000/- lakh i.e., (Rs. 18,78,762/- present release and Rs.1,21,238/- unspent balance of previous grant-in-aid), to this Department by March, 2015. The unspent balance of Rs. 1,21,238/- has been adjusted in the grant-in-aid for Rs. 20,00,000/- sanction during 2014-15.

(b) Rules and Regulations as per GFR would be applicable.

(vii) The funds allocated under this Scheme cannot be diverted to any other programmes without prior approval of Government of India. Further, Himachal Pradesh University Shimla will strictly adhere to timelines without escalation in cost and delays for completion of the work.

(viii) Himachal Pradesh University, Shimla will confirm that the conditions mentioned in the Sanction Order are acceptable to them and they are exempted from executing the bond.

(ix) The grant-in-aid is further subject to the following conditions:-

- (a) The payment may be restricted as per actual paid by Himachal Pradesh University, Shimla
- (b) Himachal Pradesh University, Shimla will provide details of expenditure.
- (c) Himachal Pradesh University, Shimla will follow the time schedule approved for making Accessibility Compliant Web Portal of Himachal Pradesh University.
- (d) Himachal Pradesh University, Shimla will furnish monthly feed back of the activities to the Department of Disability Affairs.

5. The Expenditure involved will be met from within the Sanctioned Budget of Ministry of Social Justice & Empowerment under Demand No 91, Major Head 2235: Social Security & Welfare 02- Social Welfare (Sub-Major Head), 101: Welfare of Handicapped, (Minor Head) 10-Other Schemes-10.15.31- Schemes for Implementation of Persons with Disabilities Act, 1995, Grant-in-aid for the year 2014-15 (Plan).

6. Arrangement be made to credit the amount of Rs.18,78,762/- (Rupees Eighteen Lakh Seventy Eight Thousand Seven Hundred Sixty Two only) to Himachal Pradesh University, Shimla-171 005 in accordance with the procedure laid down in the Ministry of Finance O.M. No.2 (45)/76-Spl. Cell dated 30.08.1976 as modified vide O.M. of even number dated 16.09.1976 under intimation to this Section.

7. This sanction issues with the concurrence of Integrated Finance Division of Ministry of Social Justice and Empowerment vide their Dy. No. 2490/JS&FA/2014 dated 15.09.2014.
