2. Purpose for which this grant is sanctioned: For Skill Development Training of 8500 through National Handicapped Finance and Development Corporation (NHFDC), Red Cross Road, Sec-12, Faridabad-121 007.

4. The Grants-in-aid will be regulated in accordance with the provisions contained in the General Financial Rules (GFR), 2005. The Grants-in-aid is also subject to the Chapter 9 of the General Financial Rules, 2005, as amended from time to time and read with the Government of India's decisions incorporated there-under, and any other guidelines which may be issued in this regard, and in particular to the following conditions: -

i) All relevant information and documents /certificates as required under GFR 2009 have been received.

ii) Certified that the pattern of assistance of rules governing such grants-in-aid have received the approval of the Ministry of Finance, as required under Govt. of India Decision No. (1) under DFPR-Rule 20.

iii) The accounts of the National Handicapped Finance and Development Corporation (NHFDC), Red Cross Road, Sec-12, Faridabad-121 007 shall be open for audit by C&AG or by any person authorized by him on his behalf in accordance with the provisions laid down in Section 14 of the C&AG (DPC Act 1971) as amended from time to time.

iv) The accounts of the National Handicapped Finance and Development Corporation (NHFDC), Red Cross Road, Sec-12, Faridabad shall be open for inspection by the Sanctioning Authority and Audit, both by any other Comptroller & Auditor General of India under the provision of C&AG (DPC Act, 1971) and Internal Audit by the Principal Accounts Office of the Ministry or Department whenever it is called upon to do so.

v) Grants-in-aid to National Handicapped Finance and Development Corporation (NHFDC), Red Cross Road, Sec-12, Faridabad-121 007 is subject to the economy instructions issued from time to time by the Ministry of Finance or by any other Competent Authority.

(vi) (a) National Handicapped Finance and Development Corporation (NHFDC), Red Cross Road, Sec-12, Faridabad shall complete the training programme within stipulated time and on completion of the programme National Handicapped Finance and Development Corporation (NHFDC), Red Cross Road, Sec-12, Faridabad will furnish Utilization Certificate and requisite details of beneficiaries to this Department.

(b) Rules and Regulations as per GFR would be applicable and followed by NHFDC in utilization of the grant-in-aid.

(vi) National Handicapped Finance and Development Corporation (NHFDC), has not been released any grant-in-aid under the Scheme previously.


(viii) National Handicapped Finance and Development Corporation (NHFDC), Red Cross Road, Sec-12, Faridabad has no utilization certificate as due for submission under the rules under the schemes and other programmes for Welfare of Handicapped of Ministry of Social Justice & Empowerment.

(ix) The funds allocated under this Scheme cannot be diverted to any other programmes without prior approval of Government of India. Further, it is also advised to strictly adhere to timelines without escalation in cost and delays.

- (b) National Handicapped Finance and Development Corporation (NHFDC), Red Cross Road, Sec-12, Faridabad-121 007 will provide details of expenditure and details of beneficiaries covered.
- (c) National Handicapped Finance and Development Corporation (NHFDC), Red Cross Road, Sec-12, Faridabad-121 007 will furnish feed back and progress report of the activities to the Department of Disability Affairs.
- (d) Expenditure on scheme should be made strictly as per GFR provisions & approved scheme guidelines.
