Subject: Release of Grant-in-Aid (non-recurring) to the Government of Rajasthan for making buildings accessible to the Persons with Disabilities under the SIPDA Scheme during 2014-15.

Sir,

I am directed to convey the sanction of President of India to release of **Rs.1,45,00,000/- (Rupees One Crore and Forty Five Lakh only)** as 1st installment of the total amount of Rs.291.56 Lakh (Rupees Two Crores Ninety One Lakh and Fifty Six Thousand only) sanctioned to the Government of Rajasthan for creation of barrier-free environment, for Persons with Disabilities under the Scheme for Implementation of Persons with Disability Act, 1995 (SIPDA) during 2014-15. Further release of grant-in-aid as 2nd installment will be considered by this Ministry after utilization of grant-in-aid released during 2011-12 and 2013-14 to the State Govt. of Rajasthan.

2. The detailed break-up of **Rs.1,45,00,000/- (Rupees One Crore and Forty Five Lakh only)** is at **Annexure-I**.

3. It is requested that arrangement may kindly be made to credit this amount in the Bank Account of the Government of Rajasthan in accordance with the procedure laid down in the Ministry of Finance O.M. 2(45)76-Spl.Cell dated 30.05.76 as modified vide their O.M. of even number dated 16.09.76, under information to this Section.

4. Name of the Scheme: Scheme arising out of Implementation of PWD Act, 1995 (SIPDA).

5. Purpose for which this grant is sanctioned: Construction of Lifts and Ramps.

6. Certified that this sanction has been noted at Sl. No. _ in Register of Grants (maintained in Form GFR-39).

7. The Grants-in-aid will be regulated in accordance with the provisions contained in the General Financial Rules (GFR), 2005. The Grants-in-aid is also subject to the Chapter 9 of the General Financial Rules, 2005, as amended from time to time and read with the Government of India's decisions incorporated there-under, and any other guidelines which may be issued in this regard, and in particular to the following conditions: -

i) All relevant information and documents /certificates as required under GFR 209 have been received.

Certified that the pattern of assistance of rules governing such grants-in-aid have received the approval of the Ministry of Finance, as required under Govt. of India Decision No. (1) under DFPR-Rule 20.

iii) The accounts of the Government of Rajasthan shall be open for audit by C&AG or by any person authorized by him on his behalf in accordance with the provisions laid down in Section 14 of the C&AG (DPC Act 1971) as amended from time to time.

iv) The Accounts of the Government of Rajasthan shall be open for inspection by the Sanctioning Authority and Audit, both by any other Comptroller & Auditor General of India under the provision of C&AG (DPC Act, 1971) and Internal Audit by the Principal Accounts Office of the Ministry or Department whenever it is called upon to do so.

v) Grants-in-aid to the Government of Rajasthan are subject to the economy instructions issued from time to time by the Ministry of Finance or by any other Competent Authority.

- vi) (a) The work should be completed within 6 months from the receipt of the funds.
 (b) On completion of the work the Government of Rajasthan will furnish an audited Utilization Certificate within a period of 6 months of the release of funds along with a report mentioning that the work has been completed.
 (c) The Government of Rajasthan shall furnish to this Ministry monthly progress report on the project indicating both physical and financial achievements in relation to the approved project.
 (d) The work has to be allotted as per terms and conditions laid down in General Financial Rules (GFR).
 (e) All other terms and conditions as laid down in GFR would be applicable.

vii) The Government of Rajasthan will confirm that the conditions mentioned in the letter are acceptable to them. The Government of Rajasthan exempted from executing the bond, to the Government of India.

8. The Govt. of Rajasthan was released grant-in-aid for Rs.233.13 lakh in three installments of Rs.117.84 lakh, Rs.54.43 and Rs. 60.86 lakh during 2011-12 under the Scheme. Govt. of Rajasthan had sought approval of the Ministry for re-valuation and utilization of the grants during 2013-14. The Ministry conveyed the approval vide letter dated 20.8.2013. **The Govt. of Rajasthan is required to submit the Utilization Certificate by March, 2015.** Further, Govt. of Rajasthan has been released grant-in-aid for Rs.23.394 lakh during 2013-14 vide sanction order dated 21.3.2014 for which submission of UC is due by March, 2015. Accordingly, IFD of the Ministry have concurred in the proposal to release 50% of grant-in-aid i.e., Rs.145.00 lakh during 2014-15 subject to the condition that further release may be considered after utilization of grant-in-aid released during 2011-12 and 2013-14.
