iii) The accounts of the Government of Gujarat shall be open for audit by C&AG or by any person authorized by him on his behalf in accordance with the provisions laid down in Section 14 of the C&AG (DPC Act 1971) as amended from time to time.


iv) The Accounts of the Government of Gujarat shall be open for inspection by the Sanctioning Authority and Audit, both by any other Comptroller & Auditor General of India under the provision of C&AG (DPC Act, 1971) and Internal Audit by the Principal Accounts Office of the Ministry or Department whenever it is called upon to do so.

v) Grants-in-aid to the Government of Gujarat are subject to the economy instructions issued from time to time by the Ministry of Finance or by any other Competent Authority.

- (a) The Implementing Agency shall submit the final Utilization Certificate for the entire grant along with a project completion report within three months after completion of the work/project as stipulated in the proposal. Unutilized money, if any, is to be refunded to the Ministry. In case the work/project is not completed within the stipulated timeframe and further time is sought to complete the same, the organization concerned has to intimate the Ministry and also explain the reason for the delay. If the project is not completed within the timeframe/extended timeframe, the organization concerned has to refund the grant forthwith.

- (e) The Implementing Agency will maintain a website and prominently display details of grant-in-aid received, purpose thereof, events organized and list of beneficiaries, wherever applicable.

vii) The Government of Gujarat will confirm that the conditions mentioned in the letter are acceptable to them. The Government of Gujarat is exempted from executing the bond, to the Government of India.

7. An amount of Rs. 2.62 crore was released to the Govt. of Gujarat during 2010-11 for creation for barriers free Environment, for which the Govt. of Gujarat has not sent the Utilization Certificate.
