**Minutes of the 9<sup>th</sup> Meeting of the Committee for Grants under Awareness Generation & Publicity Scheme held on 4<sup>th</sup> November, 2015 in Paryavaran Bhawan, New Delhi.**

2. At the outset, Joint Secretary, Department of Empowerment of Persons with Disabilities welcomed all the participants to the meeting and briefly outlined the salient features of Awareness Generation & Publicity Scheme. Under the Awareness Generation & Publicity Scheme, financial assistance can be given for various activities including setting up of a help line for online counseling of the PwDs, content development, publications and news media, organizing national events, participation in the international initiatives or to support various schemes organized by NGOs or self-help groups, volunteer service / outreach programme for sensitizing commercial establishment and employers, recreation and tourism, participation in community radio, press / media tours etc.

3. The following decisions were taken/observations were made:-
