

5. The above sanction is subject to the following conditions.

- (a) That Department of Disability Affairs has introduced a scheme titled "Rajiv Gandhi National Fellowship for Students with Disabilities" for pursuing M.Phil/Ph.D courses. The scheme is effective from the year 2012-13.

- (b) The implementing agency responsible for selection of candidates for grant of Fellowship is the University Grants Commission whereas it is for the Department of Disability Affairs to release the fellowship amount to the selected beneficiaries.
- (c) With the approval of the Integrated Finance Division a Memorandum of Understanding has been executed between Department of Disability Affairs and Canara Bank. The Canara Bank has been designated as the nodal banker for disbursement of the fellowship amount to the selected beneficiaries.
- (d) As per the terms and conditions contained in the MOU, a savings bank account has been opened by the Department of Disability Affairs in Canara Bank in the name of "Rajiv Gandhi National Fellowship for Students with Disabilities". Department of Disability Affairs is to transfer the funds allocated to the scheme to the said savings bank account. Canara Bank is to disburse the fellowship amount direct to the bank accounts of the selected beneficiaries as per their entitlement after verification of requisite documents.
- (e) An administrative charge of 1% of the disbursed amount is payable to the Canara Bank. The sanctioned amount of Rs. 4.02 Crore (Rupees Four Crore and Two lakh only) is inclusive of the administrative charge payable to the Canara Bank.
- (f) The list of candidates selected by UGC for the RGNF has been forwarded to the Canara Bank. The list contains 176 candidates selected for the year 2012-13 and 178 candidates for the year 2013-14 to whom the fellowship amount is disbursable. Duration of fellowship is Five years in case of PH.D and two years in case of M.Phil. course.
- (g) Canara Bank shall submit the Utilisation Certificate in the format prescribed under the General Financial Rules, 2005 after disbursement of the amount of Fellowship.

6. The Utilisation Certificate is received from the bank is enclosed.

7. This issues under the powers vested in the Ministry and with the concurrence of Integrated Finance Division vide **Dy. No. 1728/JS&FA/2014 dated 30.09.2014.**
